### “Environmental Laws and Sustainable Practices”

#### Introduction

“Man has the fundamental right to freedom, equality and adequate conditions of life, in an environment of a quality that permits a life of dignity and well-being, and he bears a solemn responsibility to protect and improve the environment for present and future generations...”<sup>\*</sup> The Stockholm Declaration of 1972 was the beginning of an era of stringent environmental legislations and protection activities. It laid the foundation for the Laws of Environment in India: Water (Prevention and Control of Pollution) Act, 1974; Forest Conservation Act, 1980; Air (Prevention and Control of Pollution) Act, 1981; Environment Protection Act, 1986; and Biological Diversity Act, 2002. In addition, landmark judgments paved the way for the environment to be covered under Article 21 of the Constitution.

However, despite having a strong legal framework for environment, India ranks 177<sup>th</sup> out of 180 countries in the *Environment Performance Index, 2018*. This shows the utter failure of implementation of the laws to control environmental pollution and degradation as the pollution levels hit a new high and a large population in India has become victim of air pollution, water pollution, hazardous waste, etc.

Keeping this in view, MCMEF is organising a Training/Sensitisation Programme which will look into the Environmental laws in India, familiarise and update the participants with the latest laws and landmark judgements/directions (*Passed by National Green Tribunal, Supreme Court*), ascertain the enforcement and implementation of the same with the help of a field trip and examine the lack of enforcement – reasons for non-compliance with the laws. The programme is **open to Students currently studying in colleges/universities, Teachers, NGOs, etc.** All participants will be **awarded a certificate** by eminent persons at the end of the programme.

#### Objectives of the Training Programme

The objectives of this training programme are:

- To understand and focus on the gravity of the issues at hand with special emphasis on the laws, judgments, directions and policies
- To find solutions for environmental conservation and adopt measures for sustainable development
